• To understand why touching a locker (or any equipment/furniture) after cleaning hands is not a problem, HCWs must understand the patient zone


The Patient Zone


The patient zone contains:

- The patient
- Immediate surroundings surfaces that are touched by or in direct physical contact with the patient

-Bed rails

-Locker/chair/medical equipment







