INTRODUCTION

Welcome to the **2024/2025 ONE DAY POINT PREVALENCE STUDY** of flu and COVID-19 vaccine uptake in **RESIDENTS** based in **RESIDENTIAL CARE FACILITIES (LTCFs)** in Ireland

This survey is a point prevalence survey: this means that all the data should be collected in a single day in each unit (e.g., all data for Unit A should be collected in the same working day). If completion of the full survey over one day may not be practical for larger LTCFs, make a plan to divide the LTCF into separate wards/units and collect the data over two or three consecutive days. It is very important that the data on a particular ward/unit is collected on the same day.

Each facility selects the day(s) to undertake the survey. **The survey should be carried out in your LTCF once during the second week of December 2024, ideally between Monday, 9th and Friday, 14th of that month.** It would be very much appreciated that the data is submitted for **Friday, 10th January 2025**

The information collected in this survey will be analysed by HPSC and published in a summary report circa September 2025.

The survey should take about 5 minutes to complete, assuming you have the relevant data to hand.
