Influenza Surveillance in Ireland – Weekly Report

Influenza Week 47 2019 (18th – 24th November 2019)











Summary

All indicators of influenza activity in Ireland were at low levels during week 47 2019 (week ending 24th November 2019).

- <u>Influenza-like illness (ILI):</u> The sentinel GP influenza-like illness (ILI) consultation rate was 13.0 per 100,000 population in week 47 2019, higher than the updated rate of 8.3 per 100,000 reported during week 46 2019.
 - ILI rates were below the Irish baseline threshold (18.1 per 100,000 population).
 - ILI age specific rates were at low levels in all age groups.
- <u>GP Out of Hours:</u> The proportion of influenza–related calls to GP Out-of-Hours services was low during week 47 2019.
- National Virus Reference Laboratory (NVRL):
 - Influenza positivity reported by the NVRL was at medium levels during week 47 2019, at 12.7%.
 - Sixty-three confirmed influenza positive specimens were reported from non-sentinel sources during week 47 2019. Fifty-nine were influenza A(H3N2), three were influenza A(H1N1)pdm09 and one was influenza B (not subtyped).
 - Four confirmed influenza positive specimens were reported from the sentinel GP network during week 47 2019; three were influenza A(H3N2) and one was influenza B (not subtyped).
 - Respiratory syncytial virus (RSV) positivity has been increasing in recent weeks, as expected at this time of year. RSV activity is currently at medium levels.
 - Sporadic detections of parainfluenza virus, adenovirus and human metapneumovirus (hMPV) have been reported to date this season.
- <u>Hospitalisations</u>: During week 47 2019, 29 confirmed influenza hospitalised cases were notified to HPSC. During the 2019/2020 influenza season to date, 70 confirmed influenza hospitalised cases have been notified to HPSC.
- <u>Critical care admissions:</u> No confirmed influenza cases were admitted to critical care units and reported to HPSC during week 47 2019.
- Mortality: There were no reports of influenza-associated deaths during week 47 2019 or during the 2019/2020 influenza season to date.
- Outbreaks: No influenza outbreak was reported to HPSC during week 47 2019.
- <u>International</u>: As is usual for this time of year, influenza activity is at low levels in the temperate zone of the northern hemisphere.

1. GP sentinel surveillance system - Clinical Data




Figure 1: ILI sentinel GP consultation rates per 100,000 population, baseline ILI threshold, medium and high intensity ILI thresholds^{*} and number of positive influenza A and B specimens tested by the NVRL, by influenza week and season. Source: ICGP and NVRL

- During week 47 2019, 30 influenza-like illness (ILI) cases were reported by sentinel GPs, corresponding to an ILI consultation rate of 13.0 per 100,000 population, higher than the updated rate of 8.3 per 100,000 reported for week 46 2019. The ILI rate for week 47 2019 is below the Irish baseline ILI threshold (18.1/100,000 population) (figure 1).




Figure 2: Age specific sentinel GP ILI consultation rate per 100,000 population by week during the summer of 2019 and the 2019/2020 influenza season to date. *Source: ICGP*.

- ILI age specific rates were low in all age groups during week 47 2019 (figure 2).
- HPSC in consultation with the European Centre for Disease Prevention and Control (ECDC) has
 revised the Irish baseline ILI threshold for the 2019/2020 influenza season to 18.1 per 100,000
 population; this threshold indicates the likelihood that influenza is circulating in the community. The
 Moving Epidemic Method (MEM) has been adopted by ECDC to calculate thresholds for GP ILI
 consultations in a standardised approach across Europe.¹
- The baseline ILI threshold (18.1/100,000 population), medium (57.5/100,000 population) and high (86.5/100,000 population). Intensity ILI thresholds are shown in figure 1.

2. Influenza and Other Respiratory Virus Detections - NVRL




Figure 3: Number and percentage of non-sentinel RSV positive specimens detected by the NVRL during the 2019/2020 season, compared to the 2018/2019 season. Source: NVRL.

The data reported in this section for the 2019/2020 influenza season refers to sentinel and non-sentinel respiratory specimens routinely tested for influenza, respiratory syncytial virus (RSV), adenovirus, parainfluenza viruses types 1, 2, 3 & 4 (PIV-1, -2, -3 & -4) and human metapneumovirus (hMPV) by the National Virus Reference Laboratory (NVRL) (figure 3 and tables 1, 2 & 3).

- Influenza positivity reported by the NVRL was at medium levels during week 47 2019, at 12.7%.
- Sixty-three confirmed influenza A positive specimens were reported from non-sentinel sources during week 47 2019. Fifty-nine were influenza A (H3N2), three were influenza A(H1N1)pdm09 and one was influenza B (not subtyped).
- Four confirmed influenza positive specimens were reported from the sentinel GP network during week 47 2019; three were influenza A(H3N2) and one was influenza B (not subtyped). Data from the NVRL for week 47 2019 are detailed in tables 1, 2 and 3.
- Respiratory syncytial virus (RSV) positivity has been increasing during weeks 40 to 47 2019 and RSV activity is now at medium levels (figure 3).
- Sporadic detections of parainfluenza virus, adenovirus and human metapneumovirus (hMPV) have been reported to date this season (table 3).
- An increase in picornavirus positive detections, which includes both rhinoviruses and enteroviruses, was reported in September and October (data on picornaviruses are not included in this report). This increase is usually seen at this time of year in association with children returning to school.

3. Regional Influenza Activity by HSE-Area

Influenza activity is based on sentinel GP ILI consultation rates, laboratory data and outbreaks.




Figure 4: Map of provisional influenza activity by HSE-Area during influenza week 47 2019

The geographical spread of influenza/ILI during week 47 2019 is shown in figure 4. Sporadic influenza activity (based on ILI cases and/or laboratory confirmed influenza cases) was reported in by all HSE areas except for HSE-E and -MW who reported localised activity during week 47 2019.

Sentinel hospitals

The Departments of Public Health have established at least one sentinel hospital in each HSE-Area, to report data on total, emergency and respiratory admissions on a weekly basis.




Figure 5: Number of respiratory admissions reported from the sentinel hospital network and % positivity for influenza, RSV and all seasonal respiratory viruses tested* by the NVRL by week and season. Source: Departments of Public Health - Sentinel Hospitals & NVRL. *All seasonal respiratory viruses tested refer to non-sentinel respiratory specimens routinely tested by the NVRL including influenza, RSV, adenovirus, parainfluenza viruses and human metapneumovirus (hMPV). Weeks with missing data are represented by the hatched bar.

Respiratory admissions reported from a network of sentinel hospitals were at medium levels, at 396 admissions, during week 47 2019 (figure 5). This was a decrease compared to the 459 respiratory admissions reported during week 46 2019. Six hospitals reported data during week 47.

4. GP Out-Of-Hours services surveillance

The Department of Public Health in HSE-NE is collating national data on calls to nine of thirteen GP Out-of-Hours services in Ireland. Records with clinical symptoms reported as flu or influenza are extracted for analysis. This information may act as an early indicator of increased ILI activity. However, data are self-reported by callers and are not based on coded influenza diagnoses.




Figure 6: Self-reported influenza-related calls as a proportion of total calls to Out-of-Hours GP Co-ops and sentinel GP ILI consultation rate per 100,000 population by week and season. Source: GP Out-Of-Hours services in Ireland (collated by HSE-NE) & ICGP.

The proportion of influenza—related calls to GP Out-of-Hours services was at low levels during week 47 2019 at 2.0%, which remains stable compared to 1.7% reported the previous week. Five services reported data for week 47 and there were 290 calls relating to self-reported influenza (figure 6).

5. Influenza & RSV notifications

Influenza and RSV cases notifications are reported on Ireland's Computerised Infectious Disease Reporting System (CIDR), including all positive influenza /RSV specimens reported from all laboratories testing for influenza/RSV and reporting to CIDR.

Influenza and RSV notifications are reported in the <u>Weekly Infectious Disease Report for Ireland</u>. Influenza notifications were at low levels during week 47 2019, with 67 confirmed influenza cases notified. This was an increase compared to the previous week. Of the 67 cases, 21 were due to influenza A(H3N2), 40 were due to influenza A (not subtyped) and six were due to influenza B.

RSV notifications were at medium levels, with 162 cases notified during week 47 2019, an increase compared to the previous week. The number of cases of RSV notified has been increasing in recent weeks, as is usual at this time of year.

6. Influenza Hospitalisations

- 29 confirmed influenza hospitalised cases were notified to HPSC during week 47 2019, nine were due to influenza A(H3N2), 17 due to influenza A (not subtyped) and three due to influenza B.
- For the 2019/2020 season to date, 70 confirmed influenza hospitalised cases have been notified to HPSC; 34 due to influenza A(H3N2), 30 due to influenza A (not subtyped) and six due to influenza B.

7. Critical Care Surveillance

The Intensive Care Society of Ireland (ICSI) and the HSE Critical Care Programme are continuing with the enhanced surveillance system set up during the 2009 pandemic, on all critical care patients with confirmed influenza. HPSC processes and reports on this information on behalf of the regional Directors of Public Health/Medical Officers of Health.

No confirmed influenza case was admitted to critical care and reported to HPSC during week 47 2019. During 2019/2020 season to date, three influenza cases have been reported to HPSC as having been admitted to ICU. Two ICU cases were due to influenza A (not subtyped) and one was due to influenza A(H3).

8. Mortality Surveillance

Influenza-associated deaths include all deaths where influenza is reported as the primary/main cause of death by the physician or if influenza is listed anywhere on the death certificate as the cause of death. HPSC receives daily mortality data from the General Register Office (GRO) on all deaths from all causes registered in Ireland. These data have been used to monitor excess all-cause and influenza and pneumonia deaths as part of the influenza surveillance system and the European Mortality Monitoring Project. These data are provisional due to the time delay in deaths' registration in Ireland. https://www.euromomo.eu/

- There were no reports of influenza-associated deaths this season to date.
- During week 47 2019, no excess all-cause mortality was reported in Ireland after correcting GRO data for reporting delays with the standardised EuroMOMO algorithm.

9. Outbreak Surveillance

- No influenza or acute respiratory infection outbreak was reported to HPSC during week 47 2019.
- Influenza and viral respiratory outbreaks reported during the influenza 2019/2020 season to date are summarised by HSE area and by pathogen detected in Tables 4 and 5.

10. International Summary

Influenza activity was low throughout the European Region with mixed circulation of type A and B viruses but, while numbers of influenza detections are low in Europe, there are early signs of influenza B dominance in some central Asian countries. For week 46 2019, data from the 22 countries or regions reporting to the EuroMOMO project indicated that all-cause mortality was at expected levels for this time of the year.

In the temperate zone of the northern hemisphere, influenza activity remained at inter-seasonal levels in most countries. However, influenza activity continued to increase across the countries in Western Asia. Worldwide, seasonal influenza A accounted for the majority of detections, with equal proportions of influenza A(H1N1)pdm09 and A(H3N2) viruses.

National Influenza Centres (NICs) and other national influenza laboratories from 112 countries, areas or territories reported data to FluNet for the time period from 28 October 2019 to 10 November. The WHO GISRS laboratories tested more than 85126 specimens during that time period. A total of 6187 were positive for influenza viruses, of which 4608 (74.5%) were typed as influenza A and 1579 (25.5%) as influenza B. Of the sub-typed influenza A viruses, 1473 (47%) were influenza A(H1N1)pdm09 and 1664 (53%) were influenza A(H3N2). Of the characterised B viruses, 43 (6.2%) belonged to the B-Yamagata lineage and 650 (93.8%) to the B-Victoria lineage. See ECDC and WHO influenza surveillance reports for further information.

11. WHO recommendations on the composition of influenza virus vaccines

Ireland has changed from using trivalent vaccine to using quadrivalent vaccine for the 2019/2020 influenza season. Quadrivalent vaccines include a 2nd influenza B virus in addition to the 2 influenza A viruses found in trivalent vaccines.

The WHO vaccine strain selection committee recommend that quadrivalent vaccines for use in the 2019/2020 northern hemisphere influenza season contain the following:

- an A/Brisbane/02/2018 (H1N1)pdm09-like virus;
- an A/Kansas/14/2017 (H3N2)-like virus;
- a B/Colorado/06/2017-like virus (B/Victoria/2/87 lineage); and
- a B/Phuket/3073/2013-like virus (B/Yamagata/16/88 lineage).

It is recommended that the influenza B virus component of trivalent vaccines for use in the 2019-2020 northern hemisphere influenza season be a B/Colorado/06/2017-like virus.

On September 27, 2019, the WHO vaccine strain selection committee recommended quadrivalent influenza vaccines for use in the 2020 southern hemisphere influenza season contain the following:

- an A/Brisbane/02/2018 (H1N1)pdm09-like virus;
- an A/South Australia/34/2019 (H3N2)-like virus;
- a B/Washington/02/2019-like (B/Victoria lineage) virus; and
- a B/Phuket/3073/2013-like (B/Yamagata lineage) virus.

It is recommended that the influenza B virus component of trivalent vaccines for use in the 2020 southern hemisphere influenza season be a B/Washington/02/2019-like virus. https://www.who.int/influenza/vaccines/virus/recommendations/2020_south/en/
